#### Chapter 267.

An act to incorporate the Ticonic Falls Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Corporators.

William Moor, William Redington, Asa Redington, Daniel Moor, junior, William Getchell, junior, Walter Getchell, and Samuel Redington, with their associates and assigns, are hereby created a corporation by the name of the Ticonic Falls Company, with the powers and privileges, and subject to the duties and requirements incident to similar corporations.

ufacture.

Corporate name.

The corporation is authorized to carry on, at the Articles of man-Ticonic Falls in Waterville and Winslow, the manufacturing of wool, cotton, iron, lumber, meal, flour, and all other articles, and to operate for all the purposes to which water power is usually applied. And may buy, hold and possess estates, real and personal, to an amount not exceeding one million of dollars.

Real and' personal estate.

Authorized to erect and maintain a dam.

Stuice to be maintain d in good repair.

Proviso.

The corporation is empowered, upon their own land, to erect and maintain a dam across the Kennebec river at said falls for the purposes aforesaid, provided they shall at all times maintain and keep in good repair over said dam a good, safe and convenient sluice for running logs, boards and other lumber down said river; provided, that said corporation shall not take or use the lands of any other person except by consent of the owner thereof.

#### Chapter 269.

An act to incorporate the Mattawamkeag Dam Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Daniel White, Ebenezer Webster, junior, Israel Corporators. Sect. 1. Washburn, junior, John Hutchins, William B. Harlow, Abner R. Hallowell, George F. Marston, Jonathan A. Cushing, Jonathan Eddy, Henry E. Prentiss, Samuel F. Hersey, Theophilus Cushing and their associates and assigns, are hereby created a body politic by the name of the Mattawamkeag Dam Company, corporate name. with all the powers, rights and privileges of similar corporations.

Said corporation shall have the right to erect and Right to erect maintain a dam across the Mattawamkeag river, above Gordon Falls, and near a place called "Jim Skitticook," for the purpose of facilitating the transportation of logs and lumber down said river; and said corporation may improve the falls below their dam for the running of logs, by the erection of dams and side
