Chapter 271.

An act to incorporate the Newcastle Hotel Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECT. 1. E. Wilder Farley, Simon Handley, Isaac C. Wash- Corporators. burn, John Glidden, Peter Connell, John A. Glidden, Charles H. Merrill, William T. Glidden, William L. Southard, James G. Huston, Samuel W. McKown, Albert Glidden, Samuel Glidden, E. W. Shaw, Robert Dixon, William Hall, John H. Converse, Nathaniel T. Chapman, Alexander Teague, Thomas J. Merrill, their associates, successors and assigns, are hereby created a corporation by the name of the Newcastle Hotel Com- Corporate name. pany, for the purpose of building, furnishing and maintaining a public house in the town of Newcastle, in the county of Lin-And said corporation are hereby authorized and empowered to exercise all the rights, powers and privileges, conferred upon such corporation by the laws of this state, and subject to all the liabilities and restrictions thereof.

Rights, privileges and liabilities.

May hold and control real and personal estate.

Said corporation may purchase and hold real and personal estate, to an amount not exceeding twenty-five thousand dollars, with full power to manage and dispose of the same, and to be divided into such number of shares as they may determine.

SECT. 3. This act shall take effect from and after its approval by the governor.
