Chapter 170.

CHAP. 170.

Resolve in relation to the sale of township number seven, in the eleventh range of townships west from the east line of the state.

Resolved, That Cyrus S. Clark is hereby released from his personal liability to pay the balance due on four certain notes of hand bearing date September fourteenth, eighteen hundred and forty-seven, payable to Moses McDonald, treasurer of state, or his successor in that office, each for the sum of three thousand, one hundred twenty-four dollars and one cent, and due in one, two, three and four years from the date thereof; which said notes were given for part of the purchase money of township unnumber seven, in the eleventh range of townships west from the east line of the state, upon condition that the said Clark shall re-convey the land so purchased to the state, and shall also pay to the state a sum which shall be equal to three dollars per thousand feet, board measure, for stumpage for all the lumber cut on said tract since the purchase thereof by the said Clark; and said Clark shall be allowed towards that sum the money paid in eighteen hundred and forty-eight to the state, on account of stumpage cut thereon in the winter of eighteen hundred and forty-seven and eighteen hundred and forty-eight, but the advance money paid on account of said land is not to be allowed. The land again is hereby directed to transfer said Clark's notes aforesaid to the file of unavailable debts in the land office and to be retained only for the purpose of upholding the title of the state to said township and for no other purpose: *provided*, *however*, no action shall be had under the foregoing resolve until the commonwealth of Massachusetts shall authorize on her part, similar relief to said Clark.

Cyrus S. Clark released from his personal liability on four certain notes given for the purchase of township No. 7, R. 11, W. E. L. S.

Condition.

Said notes to be transferred to the file of unavailable debts in the land office.

Proviso.

Chapter 171.

Resolve in favor of certain members of the legislature who visited the state prison.

Resolved, That there be paid out of the treasury of the state the following sum, to wit: to Joseph Merrill, Oliver Bean, Benjamin Rea, Samuel Thing, Howard B. Lovejoy and Eli F. Baker, five dollars and twenty-five cents each, members of the legislature appointed to visit the state prison by a vote of the legislature, it being for expenses incurred in the performance of the duties assigned them.

Appropriation to defray expenses.
