**Chapter 181.****CHAP. 181.**

Resolves authorizing the treasurer of state to sell and dispose of United States' stock and purchase scrip of this state.

*Resolved,* That the treasurer of state is authorized at any time previous to the first day of May next, to sell and dispose of (at not less than par) the United States' stock belonging to this state.

Treasurer of state authorized to sell U. S. stock.

*Resolved,* That the treasurer of state is further authorized to use any sum or sums of money which may be received into the treasury from the sale of United States' stock, in the purchase, at public or private sale, of scrip or certificates of stock of this state, due in eighteen hundred and fifty-two, or prior to that time, when the same can be effected on such terms as he shall deem advantageous to the state; and that the governor be authorized to draw his warrant or warrants for the same, or the money may be used by the treasurer according to the provisions of this resolve.

—proceeds to be used in the purchase of scrip of the state.

**Chapter 182.**

Resolve providing for the sale of the artillery gun house in the city of Portland.

*Resolved,* That the acting quartermaster general be and he hereby is authorized to sell the artillery gun house in the city of Portland, and he is hereby required to deposit the net proceeds of said sale in the treasury of state.

Authorizing the sale of gun house in Portland.

[*Approved August 11, 1849.*]

**Chapter 183.**

Resolves to provide for the reception of the standard weights of the United States.

*Resolved,* That the treasurer of state is authorized to have prepared in his office, suitable conveniences for keeping the standard scales, to be furnished to the several states by the United States government under existing laws.

Duty of treasurer of state.

*Resolved,* That the governor is authorized to draw his warrant upon any unexpended appropriation to pay the expenses which may be incurred under the foregoing resolve.
