**Chapter 302.**

**CHAP. 302.**

An act to incorporate the Portland Society of Natural History.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

SECT. 1. John W. Chickering, William Wood, John Neal, Sylvester B. Beckett, Edward Gould, Jedediah Jewett, Charles Jones, James T. McCobb, Daniel C. Colesworthy, Edward P. Banks, William Senter, Luther Jewett, and Josiah Pennell, are hereby created a body politic and corporate by the name of the Portland Society of Natural History, for the purpose of promoting the study of natural history, with power, for such purpose to take by purchase, bequest, or otherwise, and to hold, transfer, and convey real and personal property to the amount of fifty thousand dollars.

Incorporators.

Corporate name.

SECT. 2. Such corporation shall have power to prosecute and defend suits at law and in equity; to have and to use a common seal; to make by-laws and regulations, for the management of its affairs, not repugnant to the laws of the state; and shall have all the powers and privileges, and be subject to all the duties and liabilities, belonging to similar corporations in this state.

Power and authority.

SECT. 3. Any one of the persons named in the first section of this act may call the first meeting of the corporation by giving notice thereof to each of his associates; and this act shall take effect from and after its approval by the governor.

First meeting, how called.

**Chapter 303.**

An act to amend an act entitled "an act to incorporate the city of Augusta."

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

SECT. 1. The act incorporating the city of Augusta is hereby amended by inserting in section twelve after the words "payable to said court" the words "in civil cases,"—section thirteen of said act is also amended by inserting after the word "services" whenever it occurs, the words "in civil cases,"—section fourteen is also amended by adding thereto the following—"and all warrants alleging any offense to have been committed within said city shall be made returnable before said
