Chapter 346.

An act defining the powers of justices of the peace in the city of Augusta, in certain cases.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

SECT. 1. Justices of the peace residing within the city of Augusta shall continue to hold and exercise all the jurisdiction and powers in all matters and things under the laws for the relief of poor debtors, which were held by them prior to the passage of the act amendatory of the charter of the said city, approved June seventh, eighteen hundred and fifty.

SECT. 2. The first section of said amendatory act is hereby amended by striking out after the words "residing within said city" the words then following down to and including the word "interested"-and inserting in place thereof the following--"the recorder excepted, shall take cognizance of, or exercise jurisdiction over any crime or offense, or in any civil actions, except under the authority of the United States, wherein the judge is not a party, or interested."

SECT. 3. This act shall take effect from and after its approval by the governor.

Chapter 347.

An act to incorporate the Crystal Ice Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:
