The inhabitants on the territory aforesaid shall pay all taxes legally assessed on their polls or estates that remain due and unpaid, to the collector of said town of Hartford; and all persons now living and having their homes in that part of Hartford hereby annexed to Canton, and having their lawful settlement in said town of Hartford, and also Elizabeth Griffith, now a pauper of said Hartford; and all persons who have gained a settlement in said town of Hartford, by living and to Canton. having their homes on said territory hereby annexed to Canton, shall, from and after the passage of this act, be deemed to have their lawful settlements in the town of Canton.

All persons having a residence on the territory set off, to belong

The inhabitants of the territory aforesaid, shall have their proportion of the school money now belonging to the town of Hartford, to be divided according to the number of scholars.

Chapter 355.

An act to incorporate the town of Kennebec.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

The territory included within the following de- $_{\mbox{\footnotesize Boundaries}.}$ SECT. 1. scribed boundaries, to wit: beginning on the north line of Augusta, and on the east line of a gore at the end of the third mile from Kennebec river, thence southerly on the west line of said gore to land of Bethiah Knowles, thence easterly on the north line of said Knowles to land of Sewall Longfellow, thence to the east line of said gore, thence southerly, on the east line of said Longfellow's to land of William Goldthwait, thence easterly on the north line of said Goldthwait, to the northeast corner of said Goldthwait's land, thence southerly on the east line of said Goldthwait, and on the line of land owned by Timothy Goldthwait, junior, to land of the late Salmon Rockwood, thence easterly on the north line of said Rockwood, to said Rockwood's northeast corner, thence southerly to the northwest corner of land owned by Peter Atherton in Hallow-

CHAP. 355. ell, thence southerly, to the southwest corner of a piece of land which doctor Elias Weld conveyed to Winslow Hawkes, thence southwesterly, until it strikes Jimmy's stream at the point where it intersects the north line of the great five mile lot, number twenty-two, as surveyed by Solomon Adams, thence along said stream to Jimmy's pond, thence down said pond to the outlet, thence following the outlet of said pond to Hutchinson's pond, thence south, twenty-two and a half degrees west, to the south line of Hallowell, thence westerly, on the south line of Hallowell, until it strikes Gardiner stream, and across said stream to the south line of land owned by John Collins in Litchfield, thence westerly on the south line of said Collins' land, and by that line extended, until it strikes a point in Winthrop pond, due southwest of the southeast corner of land owned by Francis Fuller in Winthrop, thence running due northeast to said southeast corner of said Fuller's land, thence northerly on the east line of said Fuller's land, thence by the east line of Captain Shaw's land, to Richard's pond, thence across said pond to the west line of land owned by Samuel Richards, on the north line of said pond, thence northerly on the west line of land owned by Oren Brainard, and also by the west line of land formerly owned by James Brainard, to land owned by Elisha Case in Readfield, thence westerly, on the south line of said Case to said Case's southwest corner, thence northerly on said Case's west line to the land of J. Whiting Winslow, thence northerly on the west line of said Winslow to said Winslow's northwest corner, thence easterly to land of widow Carr, thence northerly on the west line of said Carr, and the west line of land owned by the widow Adams, William Taylor, Joseph Knowles, Eliab Lion, junior, Elisha Prescott, Stephen Hill and William Hill, to the north line of Readfield, thence easterly on the north line of Readfield to the northwest corner of Augusta, thence easterly on the north line of Augusta to the bounds first mentioned, be and hereby is incorporated into a town by the name of Kennebec, and the inhabitants thereof are hereby vested with all the powers, privileges and immunities, which the inhabitants of other towns within this state, do or may by law enjoy.

Paupers.

All persons now chargeable as paupers to Augusta, Hallowell, Winthrop, Readfield and Litchfield, who reside within the limits of the town of Kennebec hereby created, or who, if supported at a poor house, in the city of Augusta, or in either of the said other four towns, resided within the limits

of the said town of Kennebec, when transferred to such poor house, or who, if supported by said city or either of said other four towns in any other town or place, did at the time of their last residence within the towns supporting them, reside within the limits of the town of Kennebec, shall from and after the close of the current municipal year be chargeable to the town of Kennebec.

SECT. 3. The polls and estate, real and personal, within the Polls and estates, limits of said town of Kennebec, assessed prior to the time how applied. when this act is to take effect, shall be held liable for the same, as if this act had not passed, reserving and applying for the use of the inhabitants of said town of Kennebec their just proportion of the school money during the current municipal year. school money. And the fire engine and apparatus now at the Forks in Hallowell, is to be the property of the town of Kennebec. highways also in said town of Kennebec, during the current municipal year, are to remain chargeable respectively to the city and towns from which said new town is taken.

Sect. 4. Until the next apportionment for the choice of representatives of the legislature, the town of Kennebec shall be added to the representative district composed of the towns of Readfield and Fayette, which said district shall hereafter consist of the towns of Readfield, Fayette and Kennebec, and be entitled to one representative.

SECT. 5. Any justice of the peace for the county of Kennebec, may issue his warrant to any inhabitant of the new town hereby created, directing him to notify the first meeting of the inhabitants thereof, for the transaction of town business, at some suitable and convenient place in said town; said meeting to be held as soon as may be after the passage of this act.

First meeting. how called.

SECT. 6. This act shall take effect and be in force, from and after its approval by the governor.
