#### Chapter 275.

CHAP. 375.

An act authorizing the county commissioners of the county of Franklin to reassess certain taxes.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

The county commissioners of the county of Co. commissions-SECT. 1. Franklin at their next session after the passage of this act are hereby authorized to reassess upon the unincorporated tracts and townships of land situate in said county the several amounts assessed thereon by the commissioners of said county in the year eighteen hundred and forty-nine as their proportion of the ordinary county expenses of that year, the treasurer of said county having failed to certify the same seasonably to the state treasurer, and the taxes hereby authorized to be reassessed shall be collected according to the provisions of the one hund- How collected. red and thirty-third chapter of the laws of Maine, approved August fourteenth, eighteen hundred and forty-nine, and of the eighty-eighth chapter of said laws, approved August eleventh, eighteen hundred and forty-eight, so far as the same are now in force without reference to the month in which said taxes may be reassessed.

Sect. 2. The taxes hereby authorized to be reassessed shall To be certified to be certified to the treasurer of state in like manner as is now provided by law.

SECT. 3. This act shall take effect from and after its approval by the governor.

#### Chapter 376.

An act to set off a part of the town of Bucksport in the county of Hancock and annex the same to the town of Orrington in the county of Penobscot.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Sect. 1. All that part of the town of Bucksport in the county of Hancock, lying northerly of a line commencing on the easterly range line of the fourth range of lots on the plan of said Bucksport and at the corner between said Orrington and Bucksport; thence south, twenty-nine degrees west on said range line to the corner, between lots numbered fifty-eight and fifty-nine; thence north sixty-six degrees west on line

CHAP. 376. between said number fifty-eight and fifty-nine to the range line between the third and fourth ranges of lots; thence north twenty-nine degrees east on said range line to the corner of lot thirty-eight; thence north sixty-six degrees west on the line between number thirty-eight and thirty-seven to the range line between the second and third ranges of lots; thence north twenty-nine degrees east on said range line to the corner of lot number sixteen; thence north sixty-six degrees west on the line between lots numbered fifteen and sixteen to the westerly range line; thence south twenty-nine degrees west on said range line to the corner of a gore lot; thence westerly to the corner of lot number three, in the first range; thence northerly on said first range line to William Thayer's south line; thence westerly on said Thayer's line to the west end of said Thayer's land; thence northerly on said Thayer's line to John L. Brown's land; thence westerly on said Brown's line to the westerly end of said Brown's land; thence northerly on said Brown's west line to the present line between said Orrington and Bucksport together with the inhabitants thereon, in the town of Bucksport in the county of Hancock, be, and the same hereby are set off from said town of Bucksport, and annexed to the town of Orrington in the county of Penobscot.

Legal settlements of inhabitants transferred to Orrington.

SECT. 2. All persons now dwelling and having their homes, and all persons having their legal settlements in said town of Bucksport, in consequence of having had their dwelling or homes on that portion of Bucksport set off to Orrington by this act, shall have their legal settlements transferred to the town of Orrington whether paupers or otherwise.

Liability of said inhabitants for taxes already assessed, &c.

Sect. 3. The inhabitants, residing on the territory aforesaid, shall pay to the inhabitants of Bucksport all moneys legally assessed on their polls and estates and remaining unpaid; also their joint proportion of all moneys voted to be raised at any meeting legally holden by the inhabitants of said Bucksport prior to the passage of this act, and persons duly authorized to collect said moneys or taxes, shall have the same powers in the collection of the same as if this act had not passed.

This act shall take effect from and after its ap-SECT. 4. proval by the governor.
