**Chapter 285.**CHAP. 285.

Resolve in favor of William R. Snow.

*Resolved*, That there be allowed and paid to William R. Snow, out of any money in the treasury not otherwise appropriated, the sum of eleven dollars, in payment for publishing the laws passed in the year of our Lord eighteen hundred and forty-nine and for advertising in the Frontier Journal an act providing for taking the state valuation.

[*Approved August 26, 1850.*]**Chapter 286.**

Resolve in favor of certain persons of the legislature who visited the state prison.

*Resolved*, That there be paid out of the treasury of the state, the following sums, viz :

Committee who visited the state prison.

To Thomas M. Morrow, five dollars and seventy-five cents ;

Amos Pickard, five dollars and seventy-five cents ;

Isaac Reed, five dollars and seventy-five cents ;

Robert Martin, five dollars and seventy-five cents ;

Ambrose Arnold, five dollars and seventy-five cents ;

Robert Long, five dollars and seventy-five cents ;

members of the legislature, appointed to visit the state prison, agreeable to an order passed July seventeenth, eighteen hundred and fifty.

Resolve in favor of Mrs. Lemuel B. Whitney and Mrs. James W. Babcock, heirs at law of Timothy Miller late of Cold Stream, so called, now Lowell, in the county of Penobscot.

*Resolved*, That the land agent is hereby directed to convey one settling lot to Mrs. Lemuel B. Whitney and Mrs. James W. Babcock, both of Lincoln, by their own proper names, out of any lands surveyed for settling, not taken up, to be by them selected.
