Chapter 326.

CHAP. 326.

Resolve in favor of Mark Trafton.

Resolved, That there be paid to Mark Trafton out of the Mark Trafton. treasury twelve dollars, being expenses by him incurred in sickness during the present session as member of this house.

Chapter 327.

Resolve in favor of Nehemiah Bartlett.

Resolved, That there be paid out of the treasury to Nehe-Nehemiah Bartmiah Bartlett, the sum of forty-seven dollars and thirty-three cents, it being the amount of his expenses incurred by reason of sickness while in attendance as a member of the senate at the present session of the legislature.
