**Chapter 498.**

CHAP. 498.

An act relating to the Great Falls and Conway Railroad.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

SECT. 1. The Great Falls and Conway Railroad, a corporation established and existing by force of the laws of the state of New Hampshire, be and they hereby are authorized and empowered to cross with their railroad, the Salmon Falls river, from Milton, in said state of New Hampshire near the outlet of the "three ponds" so called, into Lebanon, in this state, and thence to pass through said Lebanon a distance not exceeding three thousand feet and recross said Salmon Falls river into said Milton ; and they are hereby further authorized and empowered to take, purchase and hold so much real estate in said Lebanon for a depot and for the track of said railroad, as they may deem necessary for these purposes.

Privilege to cross into the State of Maine.

Distance limited.

May hold property.

SECT. 2. This act shall take effect from and after its approval by the governor.

**Chapter 499.**

An act to incorporate the Waterville Water Power Company.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

SECT. 1. Timothy Boutelle, Jediah Morrill, Increase S. Johnson, Samuel P. Shaw, Stephen Stark, Harrison A. Smith, James Stackpole, junior, Samuel Appleton, Calvin Gardner, Edwin Noyes, William H. Blair, Augustine Perkins, Jacob M. Crooker, Sumner Percival, Walter Getchell and William Getchell, with their associates and assigns, are hereby created a corporation by the name of the Waterville Water Power Company, with the powers and privileges, and subject to the duties and requirements incident to similar corporations.

Corporators.

Corporate name. Powers and requirements.

SECT. 2. The corporation is authorized to carry on in the town of Waterville, the manufacturing of wool, cotton, iron, lumber, meal, flour and all other articles ; and to operate for all the purposes to which water power is usually applied, and may buy, hold and possess estates real and personal to an amount not exceeding five hundred thousand dollars.

Manufacture of wool, &amp;c., authorized.

Capital not to exceed \$500,000.
