Chapter 616.

An act to incorporate the Androscoggin Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Corporators.

SECT. 1. Francis T. Purington, John C. Humphries, Woodbury P. Purington, Charles Thompson, John Coburn and A. B. Thompson, with their associates and assigns are hereby created a corporation by the name of the Androscoggin Company, with the powers and privileges, and subject to the duties and requirements incident to manufacturing corporations.

Corporate name.

SECT. 2. The corporation is authorized to carry on at the falls in the river Androscoggin in the towns of Brunswick and Topsham, the manufacture of cotton and other articles, and to operate for all the purposes to which water power is usually applied; and may hold and manage estates, real and personal, to an amount not exceeding two hundred thousand dollars.

Chapter 617.

An act to set off a part of Greene, in the county of Keunebec and annex it to Lewiston, in the county of Lincoln, and to set off a part of the town of Webster and annex it to Lewiston.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Land set off from Greene to Lewiston. SECT. I. All that part of the lot on which Alexander Dwelley of Greene resides lying in the town of Greene and county of Kennebec, is hereby set off from said town and annexed to the town of Lewiston in Lincoln county.

Lands set off from Webster to Lewiston.

- SECT. 2. All that part of the lot on which Alexander Dwelley of Greene, on which he now resides lying in the town of Webster, is hereby set off from said town and annexed to the town of Lewiston.
- Sect. 3. This act shall take effect and be in force from and after its approval by the governor.
