CHAP. 388.**Chapter 388.**

Resolve in favor of Benjamin F. Brown.

Pension.

*Resolved*, That there be allowed and paid out of the treasury of the state to Benjamin F. Brown of St. Albans, four dollars per month, for two years from the first day of January in the year of our Lord one thousand eight hundred and fifty-two, in consequence of injuries received while in the service of the state, in the year eighteen hundred and fifty.

Resolve in favor of the town Milo.

*Resolved*, That the land agent is hereby authorized and required to pay to the town of Milo, the sum of seven hundred and fifty dollars, to aid said town in building a bridge across Pleasant river in said town, *provided* the county of Piscataquis will pay said town of Milo the sum of five hundred dollars for the same purpose, *and provided further*, that said town of Milo shall build a good and sufficient bridge as aforesaid to the acceptance of the land agent. And the county commissioners of said county of Piscataquis, or any other power authorized to act in their stead, are hereby authorized to assess on the county of Piscataquis the sum of five hundred dollars for the purpose aforesaid, and direct the treasurer of said county to pay the same over to the authorities of said Milo.

Resolve authorizing a tax on the several counties of this state.

*Resolved*, That the sums annexed to the counties contained in the following schedule are hereby granted as a tax for each county respectively, to be appropriated, assessed, collected and applied for the purpose of paying the debts and necessary expenses of the same and other purposes ordered by law, to wit :

*Resolved*, That there be allowed and paid to Elisha Hilton the sum of one hundred and eight dollars, out of any money in the treasury not otherwise appropriated in payment for labor performed on the Canada road.

**Chapter 392.**

Resolve for the purchase and distribution of the Maine Register.

*Resolved*, That the secretary of state be directed to procure a suitable number of copies of the Maine Register and State Reference Book for the year eighteen hundred and fifty-two, and distribute one copy to each town and organized plantation in the state; *provided* the price shall not exceed seventy-five cents for each copy.
