Chapter 396.**CHAP. 396.**

Resolve in favor of Jewett and March.

Resolved, That the land agent be and hereby is authorized to audit the claims of Jewett and March of Bangor and make them such allowance as in his opinion shall be just and equitable.

Resolve in relation to the abuses of passengers in California steamers.

Whereas, great abuses are alledged to exist in the conveyance of passengers in the steamboats between the Atlantic ports and those of California, occasioning sickness and loss of life without precedent,—said abuses consisting chiefly in the excessive crowding of these boats with passengers—neglect of proper means of ventilation—unwholesome provisions and want of suitable attention to the sick; and

Whereas, large numbers of the citizens of this state have been and still are subject to these abuses, and it is doubted whether the laws of the United States regulating the conveyance of passengers in sailing vessels furnish any means of redress in the case, therefore

Resolved, That our senators and representatives in congress be requested to procure the speedy enactment of such laws by congress, as shall be best adapted to prevent these abuses in future, and to furnish ample and summary redress to individuals who shall hereafter be subject to them.

Resolved, That the governor be requested to forward a copy of the foregoing resolves to our senators and representatives in congress.

Resolve in favor of Silas Barnard.

Resolved, That the land agent of this state be and he hereby is authority and directed to abate the amount due said state for timber cut upon the Saint John waters under permits to said

Abatement.

CHAP. 399. Silas Barnard, dated January thirteenth, in the year of our Lord one thousand eight hundred and forty-six, and December twenty-sixth in the year of our Lord one thousand eight hundred and forty-six.
