**Chapter 430.**CHAP. 430.

Resolve in favor of plantations number twenty-one and thirty-three in the county of Hancock.

*Resolved*, That the state treasurer be and he hereby is authorized to pay out of the school fund belonging to the plantations hereinafter named, the sums following to wit: to the plantation number twenty-one the sum of twenty-five dollars and to the plantation number thirty-three the sum of forty dollars.

School fund.

**Chapter 431.**

Resolve amending the valuation of the town of Belgrade.

*Resolved*, That the state valuation of the town of Belgrade, be amended by reducing the number of taxable polls from three hundred and eighty-two, to two hundred and eighty-two.

Valuation of Belgrade reduced.

**Chapter 432.**

Resolve in favor of the Brewer Artillery.

*Resolved*, That the land agent is hereby authorized and directed to convey to the Brewer Artillery, the gun-house and lot of land upon which said house is located in the town of Brewer.

**Chapter 433.**

Resolve in favor of the town of Otisfield.

*Resolved*, That the town of Otisfield in the county of Cumberland be and hereby is authorized to collect by suit at law, or otherwise, of the town of Naples in said county of Cumberland, the proportion of the state and county taxes for the years eighteen hundred forty-nine, and eighteen hundred fifty, charge-

able upon the polls and estates, which were set off from Otisfield to Naples, by act approved July twenty-seventh eighteen hundred forty-eight; the same having been erroneously retained in the valuation of the town of Otisfield, and not transferred to the valuation of the town of Naples; and the state and county taxes assessed for said years eighteen hundred forty-nine, and eighteen hundred fifty, upon said erroneous valuation, having been actually paid by said town of Otisfield, and it is hereby declared, that the sum of forty-five dollars forty-nine cents was the proportion of the state taxes for said years, assessed on the town of Otisfield, on account of said polls and estates.

*Resolved,* That the town of Naples be and hereby is authorized to raise by taxation, whatever sums the town of Otisfield may be entitled, by virtue of the foregoing resolve, to recover from said town of Naples.

### Chapter 434.

Resolve for the repair of the military road.

*Resolved,* That the land agent is hereby authorized to expend a sum not exceeding five hundred dollars in making such repairs as he may deem necessary upon the military road and bridges between Mattawamkeag point and the south line of the town of Linneus.

Resolve in favor of Eunice Shapleigh and others.

*Resolved,* That Eunice Shapleigh, Jane Phillips, Rhoda Bailey, Abigail Butler and Reuben Jones and the heirs at law of Levi Jones and the heirs at law of Nicholas Jones the said Eunice, Jane, Rhoda, Abigail, Reuben, Levi and Nicholas being children of Tobias Jones, be and the same are hereby made and declared to be the legal heirs of Mary Carter late of Augusta, deceased, the said Mary Carter being the reputed sister of the said Tobias Jones, and that all the right, title and interest of the State of Maine in and to any real or personal estate formerly belonging to said Mary Carter is hereby given,
