Chapter 451.

Resolve relating to the Maine State Prison.

Resolved, That the governor and council be authorized to audit and settle the accounts of Benjamin Carr late warden of the Maine State Prison, and if any balance be found due him that the same be paid out of the contingent fund of the governor and council.

Chapter 452.

Resolve authorizing the treasurer to make a temporary loan in behalf of the state.

Temporary loan. **Resolved**, That the treasurer of state be and he is hereby authorized to procure on the faith of the state a loan not exceeding five per cent. on the capital stock actually paid in of the several banks of this state at any time the situation of the treasury may render it necessary previous to the first Wednesday in January in the year of our Lord one thousand eight hundred and fifty-three, at a rate of interest not exceeding five per cent., and the treasurer shall pay said loan in whole or in part, whenever the condition of the treasury will permit.

Chapter 453.

Resolve abating the tax on Old Harbor and Holbrook's Islands, Hancock county.

Taxes abated.

Resolved, That the state treasurer is hereby directed to abate the state and county taxes on Holbrook's island for the year one thousand eight hundred forty-seven and eight, and state taxes for the years one thousand eight hundred forty-nine, fifty, fifty-one and fifty-two; and he is also directed to abate the state taxes on Old Harbor island for the years one thousand eight hundred fifty-one and fifty-two.
