Chapter 92.

An act to authorize the town of Weld to raise money to build a road through plantation Number Four.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECT. 1. The inhabitants of the town of Weld, in the county of Franklin, are hereby authorized and empowered to raise the sum of two hundred dollars, to be expended in making the road located by the county commissioners in plantation Number Four in said county, and lying between said town of Weld and the town of Wilton. And the assessors of said town of Weld, for the time being, shall assess the said sum on the inhabitants of said town and the non-resident proprietors of lands lying therein, in the same manner as other assessments are made, and the same shall be collected in like manner as other taxes, whenever the said inhabitants, by a vote of two-thirds of all present, at a legal meeting called for that purpose, shall vote to raise said sum for the purpose above mentioned.

Authorized to aid in building road in Plantation No. 4.

Money, how assessed.

Chapter 93.

An act to set off a part of the homestead of Thomas M. Clark from Farmingdale and annex the same to West Gardiner.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECT. 1. All that part of Thomas M. Clark's farm now lying in Farmingdale, and east of the county road leading from Hallowell to Litchfield, and south of the homestead of Alden Rice, be and hereby is set off from Farmingdale and annexed to the town of West Gardiner; the inhabitants of Farmingdale to support the northerly half of said road lying in front of said land set off, and the inhabitants of West Gardiner to support the southerly half thereof.

Territory set off.

SECT. 2. The sum of two hundred dollars is hereby deducted from the state valuation of Farmingdale and added to the state valuation of West Gardiner.

Valuation adjusted.

SECT. 3. This act shall take effect from and after its approval by the governor.
