Chapter 126.

An act to set off James Russ from Milton plantation and annex him to the town of Woodstock.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Person and property set off. SECT. 1. James Russ, of Milton plantation, is hereby set off, together with lot numbered fifty-five and the north half of lot numbered fifty-four, from the aforesaid plantation, and the same is annexed to the town of Woodstock.

SECT. 2. This act shall take effect and be in force from and after its approval by the governor.

Chapter 127.

An act to make valid the location of the town roads and streets of the town of Richmond.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Streets, &c., established.

SECT. 1. The several town ways and streets in the town of Richmond, in the county of Lincoln, are hereby delared, established and made legal town ways, as the same are now severally located, constructed or traveled; and all the proceedings of the said town, or of any of its officers, in the laying out, accepting and constructing the same, are hereby declared legal and valid.

SECT. 2. This act shall take effect and be in force from and after its approval by the governor.

Chapter 128.

An act additional to an act setting off a part of the town of Industry and annexing the same to the town of New Sharon, approved March tenth, eighteen hundred and fifty-two.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Paupers, where supported. SECT. 1. The town of New Sharon shall support all paupers that gained their settlement on said territory, including Moses Presse and wife who now live in the town of Starks, together

with all others that are now chargeable or may hereafter be- Chap. 129. come chargeable as paupers, who gained their settlements by residence on said territory.

SECT. 2. The town of New Sharon shall pay all expenses in Expenses, the town of Starks or elsewhere that have arisen on account of said paupers since the annexation to said town of New Sharon.

SECT. 3. This act shall take effect and be in force from and after its approval by the governor.

Chapter 129.

An act to set off a portion of the town of Benton, and annex it to Clinton.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECT. 1. The range line between L 2 and K 1, shall be the Territory dividing line between the towns of Benton and Clinton, in the county of Kennebec, on the east side of the Sebasticook river, and that part of Benton lying north of said range line be and is hereby set off from Benton and annexed to Clinton.

Chapter 130.

An act to set off certain lands from Falmouth and annex the same to Westbrook.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECT. 1. So much of the farms of William Gowen, Peter Territory Gowen, and David H. Gowen, as now is situated in the town of Falmouth, hereby is set off from the said town of Falmouth and annexed to and made a part of the town of Westbrook. And said Gowens shall pay their proportion of all taxes, debts and liabilities of the town of Falmouth, up to the time of the separation.

This act shall take effect and be in force from and SECT. 2. after its approval by the governor.
