**Chapter 71.**

An act additional to an act to incorporate the county of Sagadahoc, passed April fourth, eighteen hundred and fifty-four.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

SECT. 1. During the current year there shall be held, at the city of Bath, in the county of Sagadahoc, three terms of the supreme judicial court as follows, to wit: on the second Tuesday of May and the third Tuesday of August, for the trial of civil and criminal business; on the third Tuesday of December for trial of civil business only; and the said court shall have the same power as it has in other counties, and may summon grand and traverse jurors to attend said terms of said court; and all suits, matters, things, and indictments, transferable to said court by section five of the act to which this is additional, shall be transferred to the term of said court to be holden on the second Tuesday of May, and shall in said court be proceeded upon as provided in said fifth section; and, until a clerk shall be appointed and qualified for said court, all writs and processes returnable to said court, may be issued by the clerk of the court for the county of Lincoln, which shall have the same effect as if legally issued by the clerk of the court for the county Sagadahoc; and all notaries public, duly qualified to act as such, residing in said county of Sagadahoc, are hereby authorized to act as if the act to which this is additional had not passed.

S. J. court, in Sagadahoc county, terms of, when to be holden.

SECT. 2. During the current year, the court of county commissioners for the county of Sagadahoc, shall be established and holden at said city of Bath, on the days and with the powers provided for in section five of the act to which this is additional; and all matters and things transferable to the court of county commissioners by section five of the act to which this is additional, shall be transferred to the said court at its first term holden as aforesaid, and be proceeded upon and finally settled in said court.

Court of county commissioners.

SECT. 3. The court of probate provided for in section four of the act to which this is additional shall be established on the approval of this act, instead of the time therein provided; and all matters and things pending in the probate court for Lincoln county, shall be acted upon and finally settled in said court as if this act had not passed.

Court of probate.

SECT. 4. This act shall take effect from and after its approval by the governor.
