PRIVATE AND SPECIAL LAWS

OF THE

STATE OF MAINE.

1854.

Said corporation may receive from any person de. Chap. 399. posits of money, and may use the same as they shall judge most beneficial to the parties making the deposits, and shall divide the income thereof amongst the said depositors, their legal representatives or assigns, in just proportion, after paying necessary expenses; and any deposit may be withdrawn at such reasonable times and in such manner as said corporation shall appoint.

SECT. 3. The first meeting of said corporation may be called by any of the persons named in this act, by personal notice to all the persons herein named, or by public notice in the Hallowell Gazette, at least seven days previous thereto. such meeting, and at subsequent meetings as said corporation Officers, may provide, such officers may be chosen as may be deemed necessary for the organization and government of said corporation; and the treasurer or other officer having charge of the Certain officers funds and deposits of said corporation shall be required to give sufficient bonds for the faithful discharge of his duties.

Chapter 399.

An act to incorporate the Maine Submarine and Wrecking Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

William H. Lunt, George Williston, Peter C. Corporators. Bradstreet, James A. Whipple and Benjamin F. Cooke, their associates, successors and assigns, are hereby created a body corporate, by the name of the Maine Submarine and Wrecking Corporate name. Company, for the purpose of relieving vessels in distress, and recovering wrecked and sunken property on the coast and in the rivers of this state, with all the powers and privileges, and Powers, subject to all the duties, restrictions and liabilities of the general laws of the state in relation to corporations.

The capital stock of said company shall not exceed capital stock. two hundred thousand dollars, to be divided into shares of one shares.

Sect. 3. Said company are hereby authorized to relieve wrecked and raise sunken vessels and other property, at the &c. request of the owners, their agents, the insurers or the com-

Chap. 400. missioners appointed under chapter forty-nine of the revised statutes of this state, on such terms as may be agreed upon by the parties; and also to recover to their own use, any vessels or other property that shall have been sunk and abandoned for the space of one year; provided, that said company shall give thirty days personal notice to the parties interested, and said parties shall not object.

This act shall take effect from and after its ap-Sect. 4. proval by the governor.

Chapter 400.

An act to provide in part for the expenditures of government.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Appropriations.

SECT. 1. In order to provide for certain acts and resolves of the legislature, requiring the payment of money from the treasury, and also to provide for the necessary expenditures of government for the current fiscal year, the following sums are hereby appropriated out of any moneys in the treasury; and the governor, with the advice and consent of the council, is hereby authorized, at any time prior to the first day of January, eighteen hundred and fifty-five, to draw his warrant upon the treasury for the same.
