Chapter 110.**CHAP. 110.**

Resolve authorizing the administrator on the estate of the late George T. Howe and the guardian of his minor children to convey certain real estate.

Resolved, That Benjamin Allen of Greene, in the county of Kennebec, administrator on the estate of George T. Howe, late of said Greene, deceased, together with the guardian of the minor children of said deceased, be and hereby are authorized and empowered to execute and deliver, in their said several capacities, to Stephen W. Howe of Leeds, in said county of Kennebec, his heirs and assigns, a deed of release of a tract of land, being a part of the following described lot, situate in said town of Leeds, and bounded as follows, viz: easterly by land of Isaac Beals; southerly by the town line between the towns of Leeds and Greene; westerly by land owned by said Stephen, and northerly by land of Nehemiah Thompson and Reuben B. Dunn or Moses Fogg. Said tract hereby authorized to be conveyed is the westerly part of said lot, and contains about twenty-one acres, and is the same set off to said Stephen by said deceased in his lifetime; and the said deed or deeds so executed shall convey to said Stephen W. Howe as good and perfect a title to said tract of land as if the said George T. had given a deed thereof to the said Stephen W. in his lifetime.

Chapter 111.

Resolve in favor of Hannah, wife of Samuel Meservey.

Resolved, That the land agent is hereby authorized to convey to Hannah, wife of Samuel Meservey, lot number twenty-nine, in the Indian township number four, upon the said agent being satisfied that neither Elizabeth Green, her heirs or assigns, have had the benefit of the resolve of the legislature heretofore passed in favor of said Elizabeth, in consideration of the revolutionary services of her husband, John Green; and that the said Hannah is sole heir of said Elizabeth, and that the certificate issued from the land office to said Elizabeth, numbered two hundred eighty one, dated twenty-ninth of March, eighteen hundred thirty-six, has been lost, and has not been transferred.
