Chapter 142.

Снар. 142.

Resolve in favor of Joshua Hathaway.

Resolved, That the land agent be authorized to lease to Joshua Hathaway and his wife during their joint lives or the survivor of them, lot numbered seventy, containing eighty acres, and a part of lot numbered seventy-one, the same now in possession of the said Hathaway, and situated in the town of Passadumkeag and county of Penobscot.

Chapter 143.

Resolve in favor of the heirs of Dorcas Farnham and of the heirs of Ruth Duren.

Resolved, That the land agent be authorized to convey to the heirs of Dorcas Farnham lot numbered thirty-one in township eight, range three, upon satisfactory evidence being produced to him that the claimants are the sole heirs of the said Dorcas Farnham, and that the said lot was not conveyed to said Dorcas Farnham in her lifetime, and that the certificate issued to her in her lifetime has not been assigned or transferred to any person, and that the same is lost; and to the heirs of Ruth Duren lot numbered one hundred and four, in said township, upon the production of similar evidence applicable to their case.

Chapter 144.

Resolve in favor of the members of the board of agriculture.

Resolved, That there be paid out of any money in the treasury not otherwise appropriated, the sum of one hundred and twenty dollars to the members of the board of agriculture for four days additional attendance at the present session of the board, seventy-one dollars to Sidney Perham and twelve dollars to Nathan Foster for travel and attendance as committee of the board, and twenty-eight dollars to Charles Turner in full for his services as messenger to the board of agriculture the present session.
