Chapter 182.

CHAP. 182.

Resolve in favor of plantations number twenty-one and thirty-three in the county of Hancock.

Resolved, That the state treasurer be and he is hereby authorized to pay out of the school fund belonging to the plantations hereinafter named, the sums following to wit: to plantation number twenty-one, the sum of fifty dollars, and to plantation number thirty-three, the sum of eighty dollars.

Chapter 183.

Resolve in favor of Ebenezer Witham and John J. Perry.

Resolved, That there be paid out of the treasury of this state to Ebenezer Witham, member of this house, the sum of five dollars; and to John J. Perry, clerk of the house, the sum of five dollars, on account of expenses incurred by them in consequence of sickness during the present session.

Chapter 184.

Resolve in favor of M. Littlefield.

Resolved, That there be paid out of the treasury of the state, out of any moneys not otherwise appropriated, to M. Littlefield the sum of eight dollars for publishing laws of the extra session and for proclamation of reform school.

Chapter 185.

Resolve in favor of the reporters of the Senate and House of Representatives.

Resolved, That there be paid out of the treasury to William H. Simpson, William T. Johnson, Daniel T. Pike and John Dorr, the sum of twenty-five dollars to each, for their services as reporters of the senate and house of representatives for the present session; and that the governor be authorized to draw his warrants therefor.
