Chap. 436. of the city, on complaint of the city marshal before the municipal court of said city.

SECT. 2. This act shall take effect from and after its approval by the governor.

Chapter 436.

An act to set off certain land from Chelsea and annex the same to Pittston.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Certain territory set off from Chelsea and annexed to Pittston. SECT. 1. John Barker, together with his farm, situated in Chelsea, in the county of Kennebec, on the fifth mile, east of the Kennebec river, and bounded on the south by the dividing line between said Chelsea and Pittston, about two hundred and thirty rods, and the west line of said farm extending northerly about eighty-six rods, and the east line of the same extending about fifty rods, as said farm is now fenced and occupied by said Barker, is hereby set off from said town of Chelsea, and annexed to Pittston in said county.

SECT. 2. This act shall take effect from and after its approval by the governor.
