CHAP. 230.

Chapter 230.

Resolves providing for a revision of the public laws of this state.

Public laws,
revision of, &c.
Commissioners,
appointment of.
—duties of, &c.

Resolved, That the governor, with the advice and consent of the council, is hereby authorized to appoint three suitable persons commissioners, whose duty it shall be faithfully to revise, collate and arrange all the public laws of this state, which are or may be in force at the time such commissioners shall finally report their doings in the premises. And such commissioners shall carefully collect the different acts and parts of acts relating to the same subject matter, and collate and arrange the same under appropriate titles, chapters and sections, and in all respects execute and complete said revision in such a manner as in their opinion will render said laws most plain, concise and intelligible.

—further duties.

Resolved, That it shall be the duty of said commissioners in the report of their doings, to indicate such contradictions, omissions or imperfections, as may appear in the laws so to be revised, and the mode in which the same may be reconciled, supplied or amended, and they shall report to the next legislature, on or before the tenth day of the session, their doings, and the governor, with the advice and consent of the council, is hereby authorized to draw his warrant on the treasury of state, from time to time, for the amount of the expenses of said commissioners, and a reasonable compensation for their services.

Index, &c.

Resolved, That the said commissioners, in case the revised code by them reported should be adopted by the legislature, with or without amendments, are hereby authorized, and it shall be their duty to prepare a suitable index, and superintend the publication of said revised code.

Resolved, That the governor, with the consent of the council, appoint some suitable person to act with the Indian agent, who shall inquire into the matter connected with the petition of Tomer Lewey, and report a statement of facts to the governor and council.
