Chapter 539.

An act additional to "An act to incorporate the Calais Gas Light Company."

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECTION 1. The Calais Gas Light Company are hereby authorized to extend their gas pipes to the line of the state, and to connect the same with the pipes of any gas company which may be established in Saint Stephen, in the Province of New Brunswick.

Gas pipes, extension of.

Connection authorized.

SECT. 2. This act shall take effect and be in force from and after its approval by the governor.

[Approved January 23, 1856.]

Chapter 540.

An act granting further powers to the proprietors of Forest Grove Cemetery.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECT. 1. The Proprietors of Forest Grove Cemetery are hereby empowered to take and hold a further amount of land, not exceeding twelve acres, for the purposes of their cemetery

Authorized to hold a further amount of real and personal estate.

CHAP. 541. in the manner provided in the act incorporating said proprietors; and personal estate to an amount not exceeding ten thousand dollars; and may cause the said land to be divided into lots not exceeding ten square rods each, to be held under like conditions as are prescribed for the lots authorized to be laid out by said act of incorporation.

Real estate, how divided.

SECT. 2. This act shall take effect and be in force on and after its approval by the governor.

[Approved January 28, 1856.]

### Chapter 541.

An act enlarging the powers of the Norway Mutual Fire Insurance Company.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

Authorized to insure all kinds of property.

SECT. 1. The Norway Mutual Fire Insurance Company are hereby authorized to insure any description of property, real or personal, against loss or damage by fire.

SECT. 2. This act shall take effect from and after its approval by the governor.

[Approved January 29, 1856.]

### Chapter 542.

An act additional to the act to incorporate the Portland Savings Bank.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

Trustees to appoint certain officers and prescribe term of office.

SECT. 1. The charter of the Portland Savings Bank is hereby so amended, that the secretary and the treasurer shall be appointed by, and shall hold their offices at the pleasure of the trustees.

SECT. 2. This act shall take effect upon its approval by the governor.
