#### Chapter 567.

CHAP. 567.

An act additional to "An act to establish the South Kennebec Agricultural Society."

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECT. 1. The act entitled "An act to establish the South Kennebec Agricultural Society," approved March twenty-ninth, amended. one thousand eight hundred and fifty-three, is hereby amended in the second section thereof, by inserting after the word "Hallowell," the words, and the city of Augusta.

SECT. 2. Any act heretofore passed whereby the said city of Augusta is embraced within the limits of any other agricultural society, is so far repealed as to render such act consistent with the provisions of the foregoing section.

This act shall take effect from and after its approval by the governor.

#### Chapter 568.

An act to incorporate Corinthian Royal Arch Chapter.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Timothy Chase, Benjamin Kelley, and Josiah Far- Corporators. row, with their associates and successors, are hereby incorporated into a body politic, by the name of Corinthian Royal Corporate name. Arch Chapter, established at Belfast, in the county of Waldo, with power to sue and be sued, to have a common seal and change the same, to make any by-laws for the management of Powers and their affairs not repugnant to the laws of this State; to take and hold for charitable and benevolent uses, any real estate to personal estate. the value of two thousand dollars, and any personal estate to the value of two thousand dollars, and to give and grant or Amount. bargain and sell the same; and with all the privileges usually granted to other societies instituted for the purposes of charity and beneficence.

SECT. 2. Timothy Chase is hereby empowered and author- First meeting, ized to fix the time and place of holding the first meeting of said corporation, and to give notice thereof in such manner as he may deem suitable.

The powers granted by this act may be enlarged, restrained or annulled, at the pleasure of the Legislature.
