CHAP. 311. Valuation of Hollis.

—of Dayton.

Resolved, That the valuation of the town of Hollis shall be two hundred fifty-one thousand eight hundred eighty-seven dollars for estate, and three hundred and forty-eight polls. The state valuation of the town of Dayton shall be one hundred sixteen thousand five hundred fifty-six dollars for estate, and one hundred and fifty polls.

Chapter 311.

Resolve in favor of the insane hospital.

Resolved, That the sum of two thousand dollars be paid out of any moneys in the treasury, not otherwise appropriated, for the purpose of making such alterations in the house connected with the hospital, known as the "cottage," so that it can be used as a wash room and laundry, and for the heating of water necessary for the hospital; and that said appropriation be expended under the direction of the trustees of the hospital.

Chapter 312.

Resolve in favor of Bickford C. Mathews.

Resolved, That the land agent be authorized and directed to convey to Bickford C. Mathews, lot numbered twenty-six, in township numbered six, range five, west from the east line of the state, containing six hundred and fifty-two acres, forfeited to the state by the original purchaser, the state having received a fair equivalent therefor from the original purchaser, and Mathews having purchased the same of a third party in good faith, on the representation that nothing was due the state thereon.

Resolve in favor of Rufus N. Sanborn.

Resolved, That there be paid out of the treasury of the state to Rufus N. Sanborn of Baldwin, the sum of six dollars per

Chapter 314.

Resolve in favor of the town of Waldoborough.

Resolved, That in consequence of the destruction by fire in Books, &c., aueighteen hundred and fifty-four, of the books belonging to the furnished. town of Waldoborough, the secretary of state is hereby directed to furnish said town with one copy of each volume of the Maine Reports, and such other books, pamphlets and maps, as are usually furnished towns by the state, so far as the same can conveniently be furnished from the volumes in the possession of the state.

Chapter 315.

Resolve in favor of the insane hospital.

Resolved, That the sum of oue thousand dollars be paid out Insano hospital, of any moneys in the treasury not otherwise appropriated, for five orgine, &c. the purchase of a fire engine for the use of the hospital establishment, and that said appropriation be expended under the direction of the trustees of the insane hospital.

Chapter 316.

Resolve to promote the education of the Penobscot Indians.

Resolved. That there be paid out of the state treasury, under Ponobacot the direction of the governor and council, to such person as they may direct, the sum of three hundred and fifty dollars, to By whom be expended by the superintending school committee of the town of Oldtown, for the purpose of maintaining among the Penobscot Indians, a school or schools for their education.
