CHAP. 322.

Proviso.

year, at great expense, a good and substantial saw mill and grist mill, in said township B. *Provided*, the said Johnston and Kidder shall select said lots, and return to the land agent a certificate of such selection, within one year from the approval of this resolve.

Chapter 323.

Resolve in favor of Constant A. McLaughlin.

Compensation
for injuries.

Resolved, That there be paid out of any money in the treasury, not otherwise appropriated, to Constant A. McLaughlin, the sum of two hundred and ten dollars, as a compensation for injuries received in aiding an officer of the peace at Lewiston, on the sixth day of May, one thousand eight hundred and fifty-four, in capturing one Thomas Hyde, then engaged in a breach of the peace.

Chapter 323.

Resolve in favor of Thomas S. Roberts.

Land agent
authorized to
convey land.Land to be
selected within
one year.

Resolved, That the land agent is hereby authorized to convey to Thomas S. Roberts, two hundred acres of land in any township belonging to the state, set apart and lotted for settlement; *provided*, said Roberts shall make the selection and give notice thereof to the land agent within one year from the date of this resolve, the same to be in full for said Roberts' claim under resolves approved July twenty-six, in the year of our Lord one thousand eight hundred and fifty, and April seven, in the year of our Lord one thousand eight hundred and fifty-four.

Chapter 324.

Resolve providing for repairing the state road through the town of Baileyville.

§200, repair of
road, by whom
expended.

Resolved, That the sum of two hundred dollars is hereby appropriated out of the treasury of this state, for the purpose of

repairing the state road through the town of Baileyville, in the county of Washington, said appropriation to be expended under the direction of the selectmen of Baileyville. And the governor and council are hereby authorized, whenever the said selectmen shall furnish satisfactory evidence to them, that they have faithfully expended the aforesaid sum on said road, to draw their warrant on the treasury in favor of the selectmen of Baileyville for the sum of two hundred dollars.

Chapter 325.

Resolve in aid of the Portland Cavalry Guards.

Resolved, That the acting quartermaster general be, and he is hereby authorized to furnish the Portland Cavalry Guards with equipments for forty-eight horses, instead of arms and equipments as provided in the first section of an act approved April nineteenth, eighteen hundred and fifty-four. And the acting quartermaster general is hereby authorized to receive from the United States government, horse equipments sufficient to equip said company in lieu of muskets, that would otherwise be received.

Quartermaster general authorized to furnish horse equipments to cavalry guards in Portland.

Chapter 326.

Resolve authorizing the land agent to sell certain lands in Bradley.

Resolved, That the land agent be, and he is hereby authorized to sell the interest of the state in any lands owned by the state in the town of Bradley, on such terms and conditions as he shall deem to be for the interest of the state.

Chapter 327.

Resolve providing for the appointment of commissioners to examine obstructions at the mouth of Stillwater stream.

Resolved, Upon the petition of A. C. Buffum and fifty others, that the governor, with advice and consent of the council, may appoint one or more commissioners, not exceeding three, with authority to examine the mouth of Stillwater stream, at Eber's
