POISON .- COUNTY COMMISSIONERS.

Chanter 44.

An act to regulate the sale and use of poison.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Every apothecary, druggist, or other person, who shall sale of poison SECT. 1. sell any arsenic, corrosive sublimate, nux vomica, strychnine, or prussic acid, shall label each parcel sold, with the name of the article, and the word "poison" legibly written or printed thereon, and Daty of apothes shall make a record of such sale in a book kept for that purpose, specifying the kind and quantity of the articles sold, and the time when, and the name of the person to whom such sale is made, which record shall be open to all persons who may wish to examine the same.

The foregoing section shall not apply to the prescrip-SECT. 2. tions of physicians, of regular standing in their profession.

SECT. 3. No person, for the purpose of killing wolves, foxes, dogs, or other animals, shall leave or deposit within two hundred rods of any highway, pasture, field, or other improved land, any of the articles of poison named in the first section of this act, under the penalty provided in the following section :

SECT. 4. Any person violating any of the provisions of this act Penalty for shall pay a fine of not less than twenty, nor more than fifty dollars, or be imprisoned in the county jail not less than thirty, nor more than sixty days; provided, nothing in this section shall be construed Proviso, to prevent the use of the articles named in this act for the destruction of insects or vermin within any building.
