CHAP. 28.**Chapter 28.**

An act to change the names of certain persons.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:*

Change of  
names.

SECT. 1. James Cousins, of Kennebunk, shall be allowed to take the name of James G. Cousins; Tileston B. Clark, of Brownville, shall be allowed to take the name of Luther William Clark; Edwin Wallis Averill, of Jefferson, shall be allowed to take the name of Edwin Wallis Boynton; Eliza J. Bangs, of Jay, shall be allowed to take the name of Eliza J. Gilman; Henry Clinton Davee, of Hebron, shall be allowed to take the name of Henry Clinton Weston; Mary Helen Davee, of Auburn, and Augusta Davee, of Minot, shall be allowed to take the surname of Weston; Clara H. Timm, of Monmouth, shall be allowed to take the name of Clara H. Mason; Harriet Emma Rockwood, of Manchester, shall be allowed to take the name of Harriet Emma Manuel; Silas Wilbur Clapp, minor son of Aaron Clapp, of Lincoln, shall be allowed to take the name of Wilbur Fremont Lovejoy; Everett O. Starkey, and Edward S. Starkey, adopted children of Daniel Libbey, of Albion, shall be allowed to take the surname of Libbey; Malvina Seviah Holt, of Kenduskeag, shall be allowed to take the name of Malvina Thurston.

SECT. 2. This act shall take effect from and after its approval by the governor.

**Chapter 29.**

An act to amend the act incorporating the town of Tremont.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:*

Ch. 98, sec. 2,  
laws of 1848,  
amended.

SECT. 1. In section two, chapter ninety-eight of the acts of one thousand eight hundred and forty-eight, the words "or occasional," between the words "permanent" and "pauper," are hereby erased.

SECT. 2. This act shall take effect from and after its approval by the governor.
