BIDDEFORD STEAM MILL COMPANY .- SOUTHPORT BRIDGE COMPANY.

Chapter 39.

An act to incorporate the Biddeford Steam Mill Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

That Charles C. Sawyer, John Quinby, Thomas Quinby, Corporators. SECT. 1. William Perkins, George H. Adams, their associates and successors, be, and they hereby are, constituted and made a body politic and corporate, by the name of the Biddeford Steam Mill Company, Corporate name. with all the powers and privileges, and subject to all the duties and Powers, privileges, &c. liabilities, provided in the several laws of this state regulating manufacturing corporations; and are authorized to purchase and Mayhold real and hold real and personal estate, not exceeding in value at any one rot exceeding in value at any one value \$50,000. time the sum of fifty thousand dollars; and the same may improve. lease, sell and convey, as other proprietors and owners of real estate may lawfully do.

Said company are authorized to carry on in the city Authorized to Sect. 2. of Biddeford, the manufacture of lumber, iron, and other metals, number, &c. paper, and also to do the various kinds of grinding usually done in a grist mill; and may erect and construct, upon their own lands, the necessary works, mills, and machinery, for that purpose; pro- Proviso. vided, that said works are so constructed as not to affect the rights of other individuals or corporations in said city of Biddeford.

SECT. 3. Any one of the above named corporators may call the First meeting, first meeting of the same, by giving each of the others notice in writing at least seven days before such meeting.

SECT. 4. This act shall take effect from and after its approval by the governor.

Chapter 40.

An act to incorporate the Southport Bridge Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

Cyrus McKown, Thomas Marr, junior, James Orne Corporators. SECT. 1. and William Pierce, their associates, successors and assigns, are hereby created a corporation by the name of the Southport Bridge corporate name. Company, and by that name may sue and be sued, have and use a Powers, privicommon seal, and at any meeting choose all officers necessary to manage their business, and make by-laws for regulating their affairs,
