**Chapter 46.**

An act to set off Josiah A. Judkins, together with certain real estate, from the town of Roxbury to the town of Mexico.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

SECT. 1. Josiah A. Judkins, together with the real estate situated in Roxbury aforesaid, inclosed by the bound hereinafter described as follows, to wit: commencing on the town line between Roxbury and Mexico, at a station or point about four rods easterly from said Judkins' dwelling-house, situated in said Roxbury and Mexico; thence running north thirty-nine degrees east, three rods; thence north twenty-four degrees east, twelve rods; thence north forty-three degrees west, nine rods and twenty links; thence south sixty-seven degrees west, twenty-five and a half rods, to said town line; thence south sixty-six degrees east, twenty-six rods, on said town line to the station or point aforesaid, is hereby set off from the town of Roxbury and annexed to the town of Mexico.

Certain lands set off from the town of Roxbury to the town of Mexico. —boundaries.

SECT. 2. This act shall take effect and be in force from and after its approval by the governor.

**Chapter 47.**

An act to incorporate the International Hotel Company.

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

SECT. 1. John M. Wood, St. John Smith, John B. Brown, Thomas Amory Deblois, William Pitt Fessenden, Josiah S. Little, Nathan Cummings, Samuel P. Shaw, Nathan Clifford and Franklin C. Moody, their associates and successors, are hereby incorporated and made a body politic, by the name of the International Hotel Company, for the purpose of erecting and maintaining a house of entertainment, or hotel, in the city of Portland.

Corporators.

Corporate name.

SECT. 2. Said corporation may hold real and personal estate to the amount of three hundred thousand dollars in value; shall have all the powers and privileges, and be subject to all the duties and liabilities of corporations, as defined by the laws of this state.

May hold real and personal estate to the amount of \$300,000.

Powers, privileges, &c.

SECT. 3. This act shall take effect from and after its approval by the governor.
