CHAP. 82.

Chapter 82.

An act additional to an act entitled "An act to incorporate the Thomaston Bank."

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Authorized to allow directors compensation for services.

SECT. 1. The stockholders of the Thomaston Bank are hereby authorized to allow the directors of said bank such compensation for their services, as to them shall appear reasonable.

Inconsistent act repealed.

SECT. 2. So much of an act entitled "An act to incorporate the Thomaston Bank," approved February twenty-second, eighteen hundred and twenty-five, as is inconsistent with this act, is hereby repealed.

SECT. 3. This act shall take effect and be in force from and after its approval by the governor.

Chapter 83.

An act to amend the fourth section of an act entitled an act for the preservation of salmon, shad and alewives in Georges river and tributary streams.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Act of March 22, 1844, sect. 4, amended.

SECT. 1. An act entitled an act for the preservation of salmon, shad and alewives in Georges river and tributary streams, approved March the twenty-second, eighteen hundred and forty-four, is hereby amended, by striking out the two last sentences in the fourth section, beginning with the words, "and the fish wardens shall define," and inserting in lieu thereof, the following: "and the fish wardens resident in Warren shall define and describe in writing the place or places at which fish shall be taken, within the limits of said town, and cause the same to be entered upon the records of said town of Warren; and if any person shall take any of the fish aforesaid, at any other place than such place or places so defined by said fish wardens, or shall by placing any impediment in or near said fish way, or by any other means, hinder or obstruct the passage up, through or over such way or sluice between the first day of May and the fifteenth day of July in each year, without the written permission and direction of said fish wardens first had and obtained therefor, the person so offending shall forfeit and pay a penalty of twenty dollars for each and every offense.

SECT. 2. This act shall take effect and be in force from and after its approval by the governor.
