## PRIVATE AND SPECIAL LAWS

Снар. 126.

United States for the purpose of carrying out an act of congress, of March third, eighteen hundred and fifty-seven, providing for the erection of "fortifications at the mouth of the Kennebec river. Maine," by building and maintaining thereon forts, magazines, arsenals, dock yards, wharves and other structures, with their appendages, and over all the contiguous shores, flats and waters, within four hundred yards from low water mark; and all right, title and claim, which this state may have to, or in the said "Hog Island Ledge," in Portland harbor, and said tract or tracts at or near the entrance to Kennebec river, are hereby granted to the United States; provided, that this state shall retain a concurrent jurisdiction with the United States, in and over all the premises aforesaid, so far as that all civil processes, and such criminal process as may issue, under the authority of this state, against any person or persons charged with crimes committed without the premises aforesaid, may be executed therein in the same way and manner as if jurisdiction had not been ceded as aforesaid.

Proviso.

Taxes, exempt

SECT. 2. The premises over which jurisdiction is granted by this act, and all structures and other property thereon, shall be exonerated and discharged from all taxes and assessments which may be laid or imposed, under the authority of this state, while said premises shall remain the property of the United States, and shall be used for the purposes intended by this act.

SECT. 3. This act shall take effect from and after its approval by the governor.

#### Chapter 126.

An act to incorporate the Greenwood Cemetery Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Corporators.

By-laws.

May hold real and personal estate, value of \$50,000.

Corporate name.

SECT. 1. John M. Frye, Alonzo Garcelon, A. H. Kelsey, William R. Frye, Daniel Holland, Amos Nevins, Daniel H. Hamilton, Ammi R. Nash, Samuel R. Bearce and Samuel Haley, all of Lewiston, with their associates and successors, are hereby incorporated into a body politic, by the name of the Greenwood Cemetery Company; with power to sue and be sued; to have a common seal, and to change the same; to make any by-laws for the government of said corporation not repugnant to the laws of the state; and to purchase and hold real estate and personal property, in said town of Lewiston, to the value of fifty thousand dollars.

SECT. 2. Samuel Haley is hereby authorized to call the first meeting of said corporation, by posting up notices of the same in how called. two public places in said Lewiston, at least seven days previous thereto.

This act shall take effect from and after its approval SECT. 3. by the governor.

#### Chapter 127.

An act to provide in part for the expenditures of the government.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECT. 1. In order to provide for several acts and resolves of the Appropriations. legislature, requiring the payment of money from the treasury, and also to provide for the necessary expenditures of government for the current fiscal year, the following sums are hereby appropriated out of any moneys in the treasury; and the governor, with advice and consent of the council, is hereby authorized, at any time prior to the first day of January next, to draw his warrant upon the treasury for the same.
