Chapter 71.

Снар. 71.

Resolve in favor of Sarah W. Stone.

Resolved, That there be paid out of the treasury of this state, to Sarah W. Stone, the sum of seventy-five dollars, it being for expenses incurred in consequence of the sickness and burial of Samuel B. Stone, late a member of the house of representatives.

. Chapter 72.

Resolve for increasing the permanent school fund of this state.

Resolved, That twenty per cent. of all moneys hereafter accruing school fund, from the sale of the public lands, shall be paid over to the treasurer of state, and that said proceeds be and are hereby appropriated as a permanent school fund for the benefit of common schools, the interest of which shall be paid over annually for their use, in the same manner as the interest on the school fund is now paid.

Chapter 73.

Resolve in favor of Hannah Murphy.

Resolved. That the land agent be hereby authorized and directed Hannah Murphy, to convey to Hannah Murphy of Tremont, two hundred acres of land out of any lands that have been or may be appropriated to revolutionary soldiers; provided, the said Hannah shall within one Proviso. year from the date of this resolve, prove her claim as required by a resolve approved March seventeen, eighteen hundred thirty-five, also a resolve approved March twenty-third, eighteen hundred thirtyeight.

Chapter 74.

Resolve in favor of Franklin Adams.

Resolved, That the land agent be authorized to grant permission Franklin Adams, to Franklin Adams to cut and haul from township numbered three, grant permit to, in the fifth range, north of Bingham's Kennebec Purchase, twelve timber.

hundred thousand feet of pine timber, to be taken off within four years from the passage of this resolve, and the foregoing amount of timber is to include the timber hereafter cut by virtue of a permit from the land agent of Massachusetts to the said Adams, dated July seventeenth, eighteen hundred and fifty-two.

Chapter 75.

Resolve in favor of Samuel W. Jones.

Samuel W. Jones, in favor of. Resolved, That there be paid from the state treasury to Samuel W. Jones, from any money not otherwise appropriated, eight dollars and ninety cents, in full for his claim upon the state for taxes overpaid from the year eighteen hundred and forty-two to eighteen hundred and fifty-two, inclusive.

Chapter 76.

Resolve in favor of John Parrs.

John Parrs, in favor of.

Resolved, That the land agent be authorized to relinquish to John Parrs of Portland, all the right, title and interest which the state now has in and to certain real estate in said Portland viz: a small house and lot situate in the rear of the Abyssinian church, and another small parcel of land, near the burying ground, adjoining land now or formerly owned by S. Longfellow, and by land of Leonard R. White, being the estate of which one Margaret Johnson died seized and possessed, and which has escheated to the state.

Chapter 77.

Resolve making an appropriation for repairs on the state arsenal at Bangor.

State arsenal at Bangor, repair of. Resolved, That the sum of two hundred and sixty-dollars be paid out of the treasury of the state for repairs to be made on the state arsenal at Bangor; the said sum to be expended under the direction of the adjutant general; and the governor is hereby authorized to-draw his warrant for the same.
