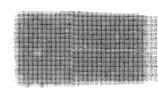

#### Chapter 292.

Снар. 292.

An act explanatory of an act incorporating the town of Somerville.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Nothing in the act incorporating the town of Somerville, approved March twenty-fifth, eighteen hundred and fifty-eight shall be construed to exonerate its inhabitants in their corporate capacity from liabilities, or deprive them of rights existing under and by virtue of their late corporate capacity of Patricktown plantation; but they may settle and adjust the same, sue and be sued therefor, in the name of the inhabitants of Somerville.

This act shall be in force from and after its approval by the governor.

### Chapter 293.

An act additional to "an act to incorporate the Lowell Bank."

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

The time for paying in the capital stock of the Lowell Capital stock, Sect. 1. Bank at Lewiston, is hereby extended until the first day of October in extended. next.

Sect. 2. This act shall take effect when approved by the governor.

## Chapter 294.

An act to authorize Timothy Lane of Vinalhaven, in the county of Walde, to erect a free bridge over tide waters from Lane's island to Vinalhaven.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Timothy Lane of Vinalhaven, in the county of Waldo, or his assigns are hereby permitted to erect and maintain a free bridge over the tide waters from Lane's island so called, across a small branch of Indian creek so called to Vinalhaven; said bridge shall be well built, of suitable width, and said Lane or his assigns shall keep a convenient draw of the width of twenty-eight feet for vessels

CHAP. 295. to pass, and a suitable pier on one side of said draw; and the said Lane or his assigns shall cause the said draw to be hoisted or opened for such vessels as may have occasion to pass through the same, free of expense and without unnecessary delay.

#### Chapter 295.

An act to incorporate the Canaan Mutual Fire Insurance Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Corporators.

Sect. 1. Wentworth Tuttle, Jr., Lysander H. Corson, George W. Johnson, Oliver Crummett, S. P. Penny, H. P. Hutchinson, James Wright, A. J. Dingley, E. G. Crowell, Ziba Burrell, C. C. Wheeler, Edward Walker, W. S. Gardner and all others who may hereafter become members of said company, in manner herein prescribed, are hereby incorporated and made a body politic, by the name of the Canaan Mutual Fire Insurance Company, for the purpose of insuring in the town of Canaan only, their respective dwelling-houses, stores, shops, barns and other buildings, household furniture, merchandize and other property the contents of any building in said town, against loss or damage by fire, whether the same happen by accident, lightning or by any other means, excepting that of design in the insured; and may purchase and hold such real and personal estate as may be necessary to effect the object of this association, and may sell and convey the same at pleasure.

Corporate name.

May hold real and personal estate.

By-laws.

SECT. 2. They may make, establish and put in execution such by-laws, not contrary to the laws of the state, as may seem necessary or convenient for the regulation and management of their affairs, and do and execute all such acts as may be necessary to carry into effect

the purposes intended by this act.

First meeting, how called.

The first meeting may be called by any three persons named in this act, by posting up in four public and conspicuous places in said town of Canaan, notice of the time, place and the business to be acted upon, at least ten days before such meeting; at which time and place the members present may elect all needful officers, fix their compensation, and manage their affairs in any way not repugnant to the laws of the state.

Officers, elec-tion of, &c.

This act shall take effect from and after its approval by the governor.
