# 1859.

Chapter 317.

FISH IN EAST MACHIAS WATERS .- FRANKLIN BANK.

An act to amend chapter three hundred and twenty of the special laws of Maine, relating to the destruction of fish in East Machias waters.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Ch. 320, special laws amended. SECT. 1. Chapter three hundred and twenty of the special laws of Maine, approved February thirteenth, eighteen hundred thirtythree, is hereby amended by striking out the seventh section of said act and inserting instead thereof the following:

Violation, nets, &c. forfeited.

- shall sell at public auction.

- proceeds how disposed of. "All nets, seines, craft, boats, barrels and salt used in taking or securing fish in violation of this act shall be forfeited, and may be seized by said committee or any one of them, when so used, and said committee shall sell at public auction, within twelve days after said seizure; and all fish so taken shall be forfeited, and sold at public auction by said committee within twelve hours after so taken, one half of the proceeds of said sale to the use of the town or plantation wherein the offence shall have been committed, and the other half to the use of the person making said seizure and sale."

SECT. 2. This act shall take effect and be in force from and after its approval by the governor.

#### Chapter 318.

An act to incorporate the Franklin Bank.

Be it cnacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECT. 1. Samuel Wheeler, William Toothaker, W. H. Josselyn, Theodore Marston, James Towle, James P. Baker, David Harlow, Winthrop Norton, Darius Howard, Seward Dill, Sheldon H. Beal, James E. Thompson, M. W. Dutton, Phillip M. Stubbs, E. K. Hitchcock, their associates, successors and assigns, are hereby incorporated into a company by the name of the President, Directors and Company of the Franklin Bank.

SECT. 2. The capital stock of said bank shall be fifty thousand dollars, divided into shares of one hundred dollars each; and said bank shall be located in the town of Phillips, in the county of Franklin.

SECT. 3. The said corporators are hereby authorized and empowered to exercise all the rights and privileges conferred upon such
