

#### Снар. 361.

#### Chapter 361.

An act to amend an act entitled an act to reduce the capital stock, and to amend the charter of the Northern Bank, approved March twenty-ninth, eighteen hundred and fifty-nine.

Be it enacted by the Sena'e and House of Representatives in Legislature assembled, as follows:

Act, approved March 29, 1859, amended.

SECT. 1. The second section of said act is hereby amended in the second line, by striking out the following words, "be reduced to seven hundred and fifty" and inserting the words "not be reduced in number but in value," so that the said section so amended, shall read:

Shares. Remaining stock to be the permanent capital. Tax, to state treasurer.

The number of shares in said bank shall not be reduced in number but in value, and the capital stock remaining after said reduction, shall continue to be the permanent capital thereof; but the said corporation shall be held to pay into the treasury of the state, the tax now required by law to be paid upon the existing capital of said bank, until the same shall be actually reduced; within ten days after the vote of the corporation for said reduction, the cashier shall file a certificate thereof verified by oath with the secretary of state.

Certificate to be filed with secretary of state.

SECT. 2. This act shall take effect when approved by the governor.

#### Chapter 362.

An act to incorporate the Portland Turnverein.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Incorporation.

The Portland Turnverein, a voluntary association now existing in the city of Portland for the improvement of its members in physical health and strength by gymnastic exercises, is hereby created a body politic and corporate by the same name, and shall have such powers and privileges, and be subject to such duties and liabilities as are granted and prescribed by the general laws of this state, relating to corporations.

Corporate name.

Powers, &c.

May hold real and personal estate.

Act how accepted.

Sect. 2. Said corporation may take and hold real and personal estate, to an amount not exceeding five thousand dollars.

This act may be accepted at any regular meeting of said association by a majority of the members present, and shall take effect from and after its approval by the governor.
