SECT. 2. This act shall take effect when approved by the governor.

Chapter 366.

An act to provide in part for the expenditures of government.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

SECT. 1. In order to provide for certain resolves of the legisla-

ture passed April fourth, eighteen hundred and fifty-nine, requiring payment of money from the treasury, the following sums are hereby appropriated out of any money in the treasury, and the governor with advice of the council is hereby authorized to draw his warrant on the treasury for the same :

SECT. 2. This act shall take effect from and after its approval by the governor.

Chapter 367.

An act to incorporate the town of Lyndon.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

SECT. 1. That part of half township H, lying west of the Aroostook river in the county of Aroostook, together with so much of the plantation of Eaton, as lies west of the Aroostook river, is hereby incorporated into a town by the name of Lyndon, and the inhabitants of said town are hereby vested with all the powers, privileges, immunities and liabilities of inhabitants of other towns.

Powers, privileges, &c.

SECT. 2. Any justice of the peace within the county of Aroostook, is hereby empowered to issue his warrant to some inhabitant of said town, directing him to notify the inhabitants thereof to meet at such time and place as he shall appoint, to choose such officers as other towns are empowered to choose at their annual meeting.

SECT. 3. This act shall be in force from and after its approval by the governor.
