If the receivers shall neglect to execute or fail to fulfill Chap. 391. any of the duties imposed upon them by virtue of the eighth sec- If receivers tion of this act, the bank commissioners may apply to any judge imposed. of the supreme judicial court to revoke the authority of said receivcommissioners. ers and appoint others in their stead, and any judge of the court on such application may so revoke the authority of the receivers and appoint others.

Sect. 10. This act shall take effect and be in force from and after its approval by the governor.

#### Chapter 391.

An act to change the names of certain persons.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Webb of Troy, shall be allowed to take the name of Octavia Smith; and Wilmot Webb, son of Octavia S. Webb, shall be allowed to take the name of Frederick Wilmot Smith; Sylvia M. Burgess of Waterville, shall be allowed to take the name of Sylvia M. Parker; Harriet A. Young of Belfast, shall be allowed to take the name of Harriet A. Patterson; Robert K. Scott, an adopted son of Robert K. Thistleward of Alexander, shall be allowed to take the name of Robert K. Thistleward; Julia A. Warner of East Livermore, shall be allowed to take the name of Julia A. Morrison; Helen M. Keith of China, shall be allowed to take the name of Helen M. Meigs; George Alden Lander of Fairfield, shall be allowed to take the name of George Laforest Wheeler.

SECT. 2. This act shall take effect when approved by the governor.
