and convey from twelve to fourteen grown persons; said last CHAP. 402. named boats shall at all times be kept in good repair; and supplied with oars and other proper appendages; and shall be so connected with the ferry boats to which they are attached that they can easily and conveniently be separated from said ferry boats in case of accident and be made available for the safety of passengers.

Said company shall forfeit and pay five dollars for each SECT. 2. and every time they shall carry any passenger or passengers on their said ferry boats without being provided with additional boats as provided in the preceding section; and shall further be liable to pay any damage suffered by any person or persons in consequence of such neglect; payment to be enforced as provided in section -how enforced. four of said act.

SECT. 3. This act shall take effect thirty days after its approval by the governor.

Chapter 402.

An act to incorporate the East Washington Agricultural Society.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

Joseph Granger, Daniel K. Chase, George Downes, SECT. 1. Giles M. Wentworth, Winthrop Young, Charles C. Porter, Gilman D. King, Gilbert H. Foster, Calvin V. Horton, Samuel T. King, Daniel Hill, Stephen B. Berry, James A. Pike, William T. King, Seth Townsend, George Washburn, Phineas H. Glover, Edward A. Barnard, Daniel Bohannon, Moses Jewett, William P. Trott, James Sargent, Isaac Bearce, B. W. Tyler, William Spring, Harris W. Anderson, John D. Lawlor, Putnam Rolfe, Dan Pineo, Asaph Sawver, Samuel Collins, together with such other persons as may join them, are hereby constituted an agricultural society, to be known by the name of the East Washington Agricultural Society.

SECT. 2. Said society is hereby established within the city of Location. Calais, the towns of Baring, Meddybemps, Cooper, Baileyville, Princeton, Alexander, Crawford, Topsfield, Robbinston, and all plantations in said county lying northerly of the towns of Cooper and Meddybemps, and may take and hold property, real or personal, to an amount the annual income of which shall not exceed one thousand dollars, to be applied to the advancement of agricultural and mechanic arts.

Said society shall have all the powers and privileges SECT. 3. Powers, privileges, &c. and be subject to all the liabilities and restrictions usually granted to and imposed upon similar societies.

WHITE LIME ROCK COMPANY .- CITY OF BATH.

SECT. 4. The first meeting of said society shall be called by Joseph Granger, or either of the persons named in the first section. by publishing a notice thereof, in the Calais Advertiser, three weeks successively, the last publication to be at least one week before the time of meeting.

SECT. 5. All acts and parts of acts inconsistent with the provisions of this act are hereby repealed.

SECT. 6. This act shall take effect and be in force from and after its approval by the governor.

Chapter 403.

An act to amend an act, entitled "an act to incorporate the White Lime Rock Company," approved April fifteen, in the year of our Lord one thousand eight hundred and fifty-four.

Be it enacted by the Senate and House of Representatives in Legis*lature assembled*, as follows:

SECT. 1. Said act is hereby amended by striking out the words "one cent" in the fourth line of the eighth section of said act, and inserting instead thereof the words two cents; so that the said section as amended shall read as follows:

All persons not members of said corporation, owning SECT. 8. quarries lying within the range or adjacent to the quarries of said corporation, and drained by their works, shall be subject to a toll to said corporation of two cents per cask upon each cask of rock so drained, when dug up by said persons. A lien for said toll is hereby created upon all rock so dug up.

Sect. 2. This act shall take effect when approved by the governor.

Chapter 404.

An act authorizing the city of Bath to elect weighers of coal, and surveyors of granite.

Be it enacted by the Senate and House of Representatives in Legis*lature assembled*, as follows:

SECT. 1. The city council of the city of Bath is hereby authorized and empowered to elect annually, one or more suitable persons, as in their judgment may be necessary, whose duty it shall be to act as weighers of anthracite and bituminous coals.
