**Chapter 365.**

CHAP. 365.

Resolve in favor of Charles D. Gilmore.

*Resolved*, That there be paid out of the treasury from money not otherwise appropriated, to Charles D. Gilmore, the sum of fifty dollars, being the sum paid into the said treasury by the said Gilmore through mistake, and under a misapprehension of the requirements of law.

Charles D. Gilmore, in favor of.

**Chapter 366.**

Resolve relating to certain academies and other literary institutions.

*Whereas*, certain academies and other literary institutions in this state holding funds in trust for the support of schools, have failed to keep such schools in operation, therefore,

*Resolved*, That the superintendent of common schools is hereby directed to obtain from said trustees a statement of the facts in the case, including the amount of funds originally placed in their hands, the amount of interest accruing therefrom, the uses which have been made of the same, and the manner in which such funds are now invested, and to present the result of his investigations in his next annual report.

Academies, &amp;c., relating to.

*Resolved*, That the superintendent of schools be directed to inquire into the standing and condition of the various chartered literary institutions in the state, the amount of funds now held in trust by them, severally, their mode of investment, the annual income of the same, and the uses made thereof; and to inquire, specially, what facilities are furnished by said institutions for the education of public school teachers, and what number of pupils in the past year have attended these institutions with special reference to becoming qualified to instruct in the public schools; and to communicate the result of his inquiries in his next annual report.

Superintendent of common schools, directed to make inquiries, &amp;c.

**Chapter 367.**

Resolve in favor of Clinton Gore plantation.

*Resolved*, That the secretary of state be directed to deliver to the clerk of Clinton Gore plantation, one copy of the revised statutes, one copy of Virgin's digest, and the other books usually furnished to towns, for the use of said plantation; *provided* such books are on hand in the library.

Clinton Gore plantation, in favor of.
