Снар. 27. -construction

SECT. 2. If the city of Bath shall erect and complete said bridge, the said city shall thereafter have the same control thereof, and be under the same liabilities to keep it in repair as if it were wholly within the limits of said city, and said city is authorized to raise money by taxation or otherwise, for the purpose of building and maintaining said bridge.

City of Bath to have control, and keep in repair.

Chapter 27.

An act to protect the property of the Kennebec Company and of the Augusta Water Power Company, in Augusta, against fire.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

No person shall enter the factory, mills, machine shops, or upon any street or property of said corporations lying below their dam in Augusta and within two hundred feet of the river. having with him a lighted pipe or cigar, or shall light or smoke any pipe or cigar thereon, under a penalty of five dollars for each offence, provided the owners of said property shall cause a notice in plain and legible characters to be affixed and kept up in four conspicuous places upon the main street passing through their property, that no smoking is allowed thereon.

Any person entering fac-tory, mills, &c., with lighted pipe,

Penalty. Notice to be posted.

If any person shall deface, remove or destroy any such notice without the permission of the owners of said property, he shall be liable to a fine of ten dollars for each offence.

Any person defacing, &c., notice. Penalty.

Prosecutions for an offence against the provisions of Prosecutions, this act shall be commenced by complaint before any municipal how commenced, court in the county of Kennebec.

Chapter 28.

An act additional to "an act to incorporate the Calais Gas Light Company."

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

The Calais Gas Light Company are hereby authorized to unite their works with those of the St. Stephens Gas Light Company in the province of New Brunswick, upon such terms as may

Sect. 2. This act shall take effect when approved by the governor.

Chapter 29.

An act to incorporate the Tyrian Lodge of free and accepted masons.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Corporators.

Sect. 1. A. Golderman, A. P. Lamb, C. Z. Hackett, E. G. Hawkes, W. C. Dwinal, Paul Grenier, S. Atwood, F. H. Cobb, G. W. Severns, John Dore, C. H. Dwinal, Timothy Waterhouse, 2d, F. E. Dwinal, J. S. Verrill, G. W. Currier, T. F. Lamb, H. B. King, I. G. Curtis, Isaiah Woodman, O. B. Dwinal, E. M. Wight and P. R. Cobb, and their associates, successors and assigns, are hereby incorporated into a body politic, by the name of Master, Wardens and Members of Tyrian Lodge of Mechanic Falls, Maine, with powers to sue and be sued, to have a common seal and to change the same, make any by-laws for the management of their affairs not contrary to the laws of this state, nor to ancient masonic usages, to take and hold for charitable and benevolent uses, any real estate to the value of two thousand dollars, and any personal estate to the value of three thousand dollars, and to give and grant or bargain and sell the same, and with all the privileges usually granted to other societies instituted for purposes of charity and benevolence.

Corporate name.

Powers, &c.

By-laws.

May hold real and personal estate.

First meeting, how called. Sect. 2. The first meeting of said corporation shall be at such time and place and be notified in such manner, as the majority of the persons above named may direct.

Sect. 3. The powers granted by this act may be enlarged, restrained or repealed at the pleasure of the legislature.

Sect. 4. This act shall take effect from and after its approval by the governor.
