an act approved March eighteenth, eighteen hundred fifty-nine, and annexed to Norway, which lies easterly and southerly of the following described line is hereby set off from said Norway and re-annexed to Paris, viz: beginning in the northerly line of said lot numbered eight, at the center of the old Rumford road, so called: thence following said center southerly till it intersects the road from Norway to South Paris; thence in a straight line through the agricultural grounds to the southeast corner thereof; thence in a straight line to the northeasterly corner of Titus O. Brown's homestead farm, so called; thence to the easterly line of his said farm to the Little Androscoggin river, and thence by said river westerly to the original line between Paris and Norway.

Снар. 55. re-annexed to

The owners of the land hereby set back shall pay all Taxes. unpaid taxes legally assessed thereon to the town of Norway; and this act shall take effect from and after its approval by the governor.

#### Chapter 55.

An act additional to an act to incorporate the proprietors of Dead River Bridge.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Sect. 1 The proprietors of the Dead River Bridge shall have the right to continue to take the tolls granted by the act to which this is additional for and during the term of twenty-five years from the approval of this act, subject to all the provisions of said act.

Authorized to take toll for the term of 25

SECT. 2. This act shall take effect from and after its approval by the governor.

### Chapter 56.

An act to incorporate the Lincoln County Bank.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Richard H. Tucker, Jr., Alexander Johnston, Andrew Corporators. Lacy, Joseph E. Smith, Henry Ingalls, Alfred Lennox, William P. Lennox, Arnold Greenleaf and Samuel E. Smith, their associates, successors and assigns, are hereby incorporated into a company by

name. Capital stock, \$50,000.

Shares. Location.

Rights, privileges, &c. the name of the President, Directors and Company of the Lincoln County Bank.

Sect. 2. The capital stock of said bank shall be fifty thousand dollars, divided into shares of one liundred dollars each; and said bank shall be located in Wiscasset, in the county of Lincoln.

Sect. 3. The said corporators are hereby authorized to exercise all the rights and privileges conferred upon such corporations by the laws of this state, and subject to all the liabilities and restrictions thereof.

#### Chapter 57.

An act authorizing the harbor-master of the city of Calais to set apart and define a ballast ground near the "Devil's Head," in the river Saint Croix.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

The harbor-master of the city of Calais, is hereby authorized to set apart a ballast ground in the river Saint Croix, near the "Devil's Head," so called, and to define the same by metes and bounds which shall be recorded in the book of records of the city of Calais, and it shall be the duty of all vessels entering said port of Calais and discharging ballast to deposit the ballast on ground so set apart and defined.

### Chapter 58.

An act to incorporate the Westport Wesleyan Aid Association.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Corporators.

Corporate name. May hold real and personal estate. Sect. 1. Mary N. Jewett, Mary F. Tarbox, Ann M. Jewett, Abby McCarty, Ruth R. Tarbox, Harriet W. Dunton, Marcia A. Dickson, Serena M. Tarbox, Philena M. Tarbox, Frances S. Tarbox, M. J. Dunton, R. A. Tarbox, their associates and successors, are hereby incorporated into a body politic by the name of the Westport Wesleyan Aid Association, with power to take and hold and to give and grant or sell and convey real estate to the value of five thousand dollars, and personal estate not exceeding the same amount, for the purpose of aiding the Methodist Episcopal Church at Westport, in the county of Lincoln, and for other reli-
