COBBOSSEE CONTEE GREAT POND .-- WATERFORD M. F. INS. CO.

CHAP. 142. a written notice to the other corporators of the time and place of such meeting at least seven days before such time arrives.

> SECT. 3. This act shall take effect and be in force from and after its approval by the governor.

Chapter 142.

An act to prevent the destruction of fish in Cobbossee Contee Great pond.

Be it enacted by the Senate and House of Representatives in Legis*lature assembled*, as follows:

SECT. 1. If any person shall between the first day of April and the first day of July following, take or destroy any pickerel or white perch in Cobbossee Contee Great pond in the county of Kennebec, or in any stream flowing into or out of said pond, by any other method than by taking them with a hook and line, he shall forfeit for each of said fish, so unlawfully taken or destroyed, a sum not less than two nor more than five dollars, to be recovered by an action of debt, one-half part thereof to the person suing for the same, and half to the town where the offence is committed.

SECT. 2. This act shall take effect from and after its approval by the governor.

Chapter 143.

An act to incorporate the Waterford Mutual Fire Insurance Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECT. 1. Daniel W. Noble, Josiah Proctor, Albert Hamlin, James M. Shaw, Peter N. Haskell, Nathaniel Rounds, John B. Sanderson, Charles W. Perry, John Holt, Eliakim Maxfield, Daniel Brown, second, John Wilkins, Joseph Hale, Amos Flint, Samuel Plummer, William W. Green, Amos Saunders, Perley W. Kilborn, Daniel B. Lebroke, Henry Sawin, John N. Baker, Emerson Wilkins, Josiah Ellsworth, Oliver Porter, John A. Douglass, Samuel Warren, their associates and successors, are hereby created a body corporate by the name of the Waterford Mutual Fire Insurance Company, with all the powers and privileges, and subject to all the duties and liabilities, prescribed in the revised statutes relating to such corporations.

Fish in Cobbossee Contee Great pond, destruction of, prohibited.

Penalty, how recovered and appropriated.

Corporators.

Said company may insure in the town of Waterford CHAP. 144. Sect. 2. only, their respective dwelling houses, stores, shops, barns and other buildings, household furniture and other merchandize, the contents of any building in said town, against loss or damage by fire, originating in any cause, other than by design in the insured.

SECT. 3. The first meeting may be called by any three persons named in this act, by posting up in three public places in said Waterford, notice of the time and place, at least ten days before such meeting, at which the members present may elect all necessary officers, fix their compensation, and do any corporate business then deemed necessary.

SECT. 4. The directors of said company at their annual meeting, Directors, duty in each year, shall make a full report of the condition of the company, giving a detailed account of their expenses, the amount of property actually insured at that time, and the amount of all debts due to and from the company, but shall not be required to publish the same in any newspaper as required in section thirty-two of chapter forty-nine of the revised statutes.

SECT. 5. No policy shall be issued by said company until applications for insurance shall have been made to the amount of twenty thousand dollars.

SECT. 6. This act shall take effect from and after its approval by the governor.

Chapter 144.

An act to prevent the destruction of pickerel in Thomas pond in the town of Waterford.

Be it enacted by the Senate and House of Representatives in Legis*lature assembled*, as follows:

SECT. 1. If any person shall take or destroy, otherwise than by hook and line, any pickerel in Thomas pond, so called, in the town of Waterford, or in any of the streams emptying into, or running out of said pond, he shall forfeit and pay for every pickerel so taken out of said pond, he shall forfert and pay for every pickerel so taken Penalty, how or destroyed a fine of one dollar, to be recovered by an action of recovered and appropriated. debt, to the use of any person who may sue for the same.

SECT. 2. This act shall take effect and be in force from and after its approval by the governor.
