- CHAP. 169.** posal or instalments of their securities and notes, the voting powers of stockholders, and for all things necessary and proper for the judicious prosecution of their business.
- Certain sections of act of incorporation repealed.** **SECT. 4.** Sections five, six, seven, ten, eleven, thirteen, sixteen, eighteen, nineteen, twenty-two, twenty-five and twenty-seven of an act entitled "an act to incorporate the Piscataqua Mutual Fire and Marine Insurance Company," be and are hereby repealed.
- Corporate name amended.** **SECT. 5.** The name of the "Piscataqua Mutual Fire and Marine Insurance Company," is hereby amended by striking therefrom the word "mutual;" and the said company shall hereafter be styled and known as the Piscataqua Fire and Marine Insurance Company; and the said Piscataqua Fire and Marine Insurance Company shall retain all the rights and privileges and be subject to all the duties and obligations now belonging to the "Piscataqua Mutual Fire and Marine Insurance Company," not pertaining to insurance upon mutual principles.

- Rights, privileges, &c.**
- Acceptance of act.** **SECT. 6.** This act shall take effect and be in force from and after its acceptance by the stockholders of said company at a legal meeting called for the purpose.

Chapter 169.

An act to change the names of certain persons.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

- Names changed.** **SECT. 1.** Huldah Page of Vassalborough, shall be allowed to take the name of Huldah Allen; Olive G. Foss of Lewiston, shall be allowed to take the name of Olive G. Davis; Mary Foss of Lewiston, shall be allowed to take the name of Mary Davis; Charles Edgar Cook Covell of Jay, shall be allowed to take the name of Edgar Cook Covell; John Francis Pennell Covell of Jay, shall be allowed to take the name of John Pennell Covell; Luther Hoar of Rangely, shall be allowed to take the name of Luther Nile; James H. Hoar of Rangely, shall be allowed to take the name of James H. Nile; Joseph J. Hoar of Rangely, shall be allowed to take the name of Joseph J. Nile; Nancy A. Hoar of Rangely, shall be allowed to take the name of Nancy A. Nile; Blanche E. Hoar of Rangely, shall be allowed to take the name of Blanche E. Nile; Hannah B. Hoar of Rangely, shall be allowed to take the name of Hannah B. Nile; Joseph Hoar of Rangely, shall be allowed to take the name of Joseph Nile.

Chapter 170.

An act additional to "an act to incorporate the city of Biddeford."

*Be it enacted by the Senate and House of Representatives in Legis-
lature assembled, as follows :*

SECT. 1. No member of the board of aldermen or of the com-
mon council of the city of Biddeford, shall, during the year for
which he was elected, be eligible by election of the city council or
either of its branches to any office of profit or emolument in said
city.

Aldermen, &c.,

SECT. 2. This act shall take effect on its approval by the gov-
ernor.

Chapter 171.

An act to amend an act entitled "an act to regulate the fishing in the Damariscotta
river in the county of Lincoln."

*Be it enacted by the Senate and House of Representatives in Legis-
lature assembled, as follows :*

SECT. 1. The fish committees of the towns of Newcastle and
Nobleborough, or persons in their employ or acting under contract
with them, shall be allowed to take fish at the usual places on the
main stream and the western branch of New River stream on each
day of the week, excepting Sunday, from the first day of May to
the fifteenth day of July of each year; but shall not at any time
take any fish in the eastern branch of New River stream.

SECT. 2. All acts and parts of acts inconsistent with the pro-
visions of this act are hereby repealed.

SECT. 3. This act shall take effect from and after its approval
by the governor.
