Chapter 142.

Resolve authorizing the sale of half lots of swamp and meadow lands unsuitable for settlement.

Resolved, That the land agent be and he is hereby authorized to sell swamp and meadow land in townships selected and surveyed for settlement, to settlers occupying adjacent lots, in quantities not exceeding eighty acres, as is now fixed by law for settling land, to be paid for in road labor in the townships where such land is situated; and upon the same terms of time as is required of settlers.

Chapter 143.

Resolve authorizing the land agent to audit the account, and pay Ferdinand Tinker for completing the bridge over the Aroostook river in the town of Maysville.

Resolved, That the land agent be authorized to audit the account Land agent authorized to of Ferdinand Tinker and pay to said Tinker a sum not exceeding settle claim of five hundred seventy-three dollars fifty-eight cents, which sum shall Tinker. be in full for all sums paid and services rendered by said Tinker in the construction and finishing said bridge.

Chapter 144.

Resolve providing for the purchase of additional copies of the new township map of Maine.

Resolved, That the secretary of state be, and he is, hereby authorized to purchase twenty-five copies of the new township map of Maine, published by J. Chace, junior, and distribute them as provided in resolve approved January third, eighteen hundred and sixty-one, entitled "a resolve to encourage the completion of the

Chapter 145.

Resolve in aid of the military road in the county of Aroostook.

Resolved, That the land agent be authorized to expend the sum of two hundred and fifty dollars in repairing the military road through township number two range three in the county of Aroostook.

[Approved March 13, 1862.]

Chapter 146.

Resolve providing for the deficiency of the agent of the Penobscot Indians for the year eighteen hundred and sixty-one.

Resolved, That there be paid from the treasury of the state to the agent of the Penobscot Indians, the sum of seven hundred ninety-three dollars and thirty-three cents, for money expended by him for the benefit of the Penobscot Indians, and not yet refunded by the state, as follows:

Repairs on building on public farm, one hundred eighty-two dollars and fifty-five cents.

Repairs on Indian chapel, forty-three dollars and eighty-three cents.

Excess of annuities beyond appropriation, eighty-one dollars and sixty-two cents.

Amount paid for seed beyond appropriation, one hundred fiftysix dollars and fifteen cents.

Amount expended for the poor and sick, in excess, two hundred ninety-three dollars and twenty-one cents.

Amount paid A. T. Palmer as per resolve, thirty-six dollars.

Said deficiency to be paid from any sum of money now accrued or that may accrue from the rent of any of the shores belonging to the Penobscot Indians; *provided* the governor and council after auditing the agent's account for the Penobscot tribe, unless already audited, shall be satisfied this amount is due said agent.
