**Chapter 147.**

CHAP. 147.

Resolve laying a tax on the several counties in this state.

*Resolved*, That the sums annexed to the counties in the following schedule are hereby granted as a tax for each county respectively, to be appropriated, assessed, collected and applied for the purpose of paying the debts and necessary expenses of the same, and other purposes ordered by law, to wit:

County taxes.

- Androscoggin, eighteen thousand dollars.
- Aroostook, six thousand dollars.
- Cumberland, fifty-three thousand dollars.
- Franklin, four thousand dollars.
- Hancock, ten thousand four hundred dollars.
- Kennebec, nineteen thousand six hundred and twenty-five dollars.
- Knox, nine thousand dollars.
- Lincoln, eleven thousand dollars.
- Oxford, twelve thousand dollars.
- Penobscot, twenty thousand dollars.
- Piscataquis, three thousand five hundred dollars.
- Sagadahoc, six thousand dollars.
- Somerset, nine thousand dollars.
- Waldo, nine thousand dollars.
- Washington, ten thousand dollars.
- York, fourteen thousand five hundred dollars.

**Chapter 148.**

Resolve in aid of building mills in township number three, range four, west of Bingham's Kennebec purchase, in the county of Franklin.

*Resolved*, That the land agent shall convey to Seward Dill, four lots of land in township number three, in the fourth range of townships west of Bingham's Kennebec purchase in the county of Franklin; *provided* that said Dill shall within two years from the passage of this resolve, erect and put in good running order a single saw mill and grist mill suited to the wants of the inhabitants upon said township, or two lots upon the completion of either of said mills.
