**Chapter 175.****CHAP. 175.**

Resolve in favor of Charles Henry Granger.

*Resolved*, That there be paid out of the treasury from any money not otherwise appropriated to Charles Henry Granger, artist, the sum of one hundred dollars in full compensation for painting the portrait of General Knox, now in the rotunda of the capitol.

Charles H. Granger, in favor of.

**Chapter 176.**

Resolve in favor of the state prison.

*Resolved*, That the sum of four thousand dollars is hereby appropriated for the purpose of procuring manufacturing stock for the use of the state prison, to be expended by the warden under the direction of the governor and council.

State prison, in favor of. Appropriation, \$4,000.

*Resolved*, That the sum of five thousand three hundred and fifty dollars, to wit: for repairs of buildings and fence, two hundred dollars; for fuel and light, six hundred dollars; for receiving and discharging prisoners, five hundred dollars; for contingent expenses, five hundred dollars; for salary of deputy warden, six hundred dollars; for five guards and two night watches, two thousand two hundred and seventy-five dollars; for salary of clerk, three hundred and seventy-five dollars; for salary of chaplain two hundred dollars; for services of physician, one hundred dollars; is hereby appropriated and placed at the disposal of the governor and council.

Further appropriation for various purposes, \$5,350.

[Approved March 19, 1862.]

**Chapter 177.**

Resolve making an appropriation for a continuance of the scientific survey of the state.

*Resolved*, That the sum of three thousand dollars be appropriated from the treasury, to be expended under the direction of the governor and secretary of the board of agriculture, in prosecuting a scientific survey of the state as contemplated in chapter eighty-four of the resolves of eighteen hundred and sixty-one.

Scientific survey, in favor of.
